Bradley Munn Foundation Fund Explained Or...WE CAN GIVE YOU MONEY!

Did you know that UNOPA has a foundation fund to help our current membership with their professional growth expenses?

The fund was established through the efforts of the University of Nebraska Foundation, the Nebraska Campaign of 1979, and the Faculty/Staff Campaign of 1980. It is sustained by generous donations from UNOPA members past and present. Several UNOPA members make donations to the fund through payroll deductions. Presently, eleven members are making donations through payroll deduction for a total of \$32.00 a month. Donations can also be made on a one-time basis, or whatever frequency you desire. The current balance of the fund is around \$8,000.

UNOPA members can submit a request for reimbursement of up to \$100 for expenses such as tuition, textbooks, workshops, professional conference expenses, and PSP application fees. Reimbursement requests are reviewed by the committee three times a year—February 15, May 15 and October 15. That makes the next review of applications February 15. You may send an application to me at any time before a deadline and I will hold the application until the next review. The rules and instructions are detailed on UNOPA's webpage, http://unopa.unl.edu/bradley-munn-professional-growth-fund.

At the discretion of the UNOPA Board, the Bradley Munn Funds can also be used to cover UNOPA's expenses when presenting or sponsoring workshops. For example, it can be used for travel expenses to bring in out-of-town presenters, honoraria for presenters, publicity of the workshop, room rental and other expenses incurred by UNOPA for a workshop.

This academic year we have had one member apply for reimbursement. A member recently applied for reimbursement of expenses she incurred while pursuing her masters degree. She will receive a \$100 check in the near future.

Please take advantage of this opportunity to have UNOPA help you with your professional growth expenses. Also, please consider donating to the foundation fund, CD #2484, via the University of Nebraska Foundation online website so that these funds are available to our membership for years to come.

Friendship Soup Mix in a Jar

Prep 30 min | Cook 1 hr | Ready In 1 hr 30 min

Recipe By: Bea Gassman

"Your friends and family will love you for this!

A soup mix in a jar recipe you can give out as gifts!"



1/2 cup dry split peas

1/3 cup beef bouillon granules

1/4 cup pearl barley

1/2 cup dry lentils

1/4 cup dried onion flakes

2 teaspoons dried Italian seasoning

1/2 cup uncooked long-grain white rice

2 bay leaves

1/2 cup uncooked alphabet pasta



Directions

- 1. In a 1 1/2 pint jar, layer the split peas, bouillon, barley, lentils, onion flakes, Italian seasoning, rice, and bay leaves. Wrap the pasta in plastic wrap, and place in the jar. Seal tightly.
- 2. Attach a label to the jar with the following instructions: Friendship Soup ADDITIONAL INGREDIENTS: 1 pound ground beef, black pepper to taste, garlic powder to taste, 1 (28 oz) can diced tomatoes-undrained, 1 (6 oz) can tomato paste, and 3 quarts water. TO PREPARE SOUP: Remove pasta from top of jar, and set aside. In a large pot over medium heat, brown beef with pepper and garlic; drain excess fat. Add diced tomatoes, tomato paste, water, and soup mix. Bring to a boil, then reduce heat to low. Cover, and simmer for 45 minutes. Stir in the pasta, cover, and simmer 15 to 20 minutes, or until the pasta, peas, lentils and barley are tender.

I'm sure many of you have seen advertisements about Escape Rooms. Maybe some of you have even taken part in an Escape Room. Last week I got to experience one of these when I was visiting my daughter and grandchildren in Michigan. What a fun, challenging, and interesting experience.

When I first heard we were going to do this, I thought, "Ok, great. This should be fun. I"m open to a new experience." But once we got there, I was a little hesitant and not sure what to expect.

My daughter chose the Pirates of the Caribbean room. We were brought into the first room and given our instructions by an enthusiastic young woman. She explained that everything in the room had a purpose but it would take us a while to figure it out. She told us what we could touch and not touch. There also was a second room that we had to figure out how to get unlocked. We had 60 minutes and we were permitted to ask for 3 clues top help us. Our main goal, of course, was to escape the second room before the 60 minutes were up.

The short story is it took us quite awhile to get going. I was totally at a loss as to how to go about this but my daughter and her boyfriend had some insight as they had been to an Escape Room before. Thank goodness. Once we got started, it was so interesting. There was a lot of hands out activity, teamwork, communication, patience, perseverance and collaboration. It was fascinating to me and I really got into it. Our team of 5 did a great job and we escaped with 8 minutes to spare.

So what were the lessons I learned:

- 1. When you don't succeed right away at something, be patient. Keep trying and use different approaches.
- 2. Good teamwork takes ongoing communication, understanding and cheering each other on.
- 3. Success doesn't come without making mistakes. There were several times we did not get it right.
- 4. Sometimes the answer is right in front of us. But we don't see it because keep looking at something the same way. We need to turn things inside out, upside down, move it sideways or remove it.
- 5. Let others take the lead and participate.
- 6. When working under pressure, you must maintain focus and be clear headed. We were under a time constraint just like you are often at work. But you must not let the pressure color your thinking.
- 7. Be open to trying new experiences. While I was hesitant at first, I ended up getting engaged in the activity. I was challenged and learned much about my own family that I had not known under regular circumstances. Things aren't always what we expect--sometimes, they are 10xs better than what we expect.

I would like to encourage you to go to an Escape Room with family members or your department team. It is a great way to bond, learn about each other and have fun! It also stimulates your creativity.
